Policy and Disclaimer:

Owner agrees to pay the rate for service provided in effect on the date pet is checked into Dragons Heart Kennels or date that service is provided. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for pet during the period said pet is in the care of Dragons Heart Kennels. Owner agrees that prior to the pet leaving the facility, all charges due will be paid by Owner or proper payment arrangements will be agreed upon by both parties in writing. Cancellations: Owner understands that all confirmed reservations must be cancelled at least three (3) days prior to my pet's reserved arrival date. Repeated cancellations will result in deposit required for future reservations. Owner further understand that a no call/no show will result in all future reservations will be cancelled.

Dragons Heart Kennels LLC pledges to give appropriate care to all boarded pets. Owner understands and agrees Owner assume all risk and not hold Dragons Heart Kennels responsible for conditions that often are unavoidable in boarding environments such as, but not limited to, problems related from ingesting materials found outdoors, weight loss, rough hair, fleas, ticks, hot spots (pyoderma), otitis, conjunctivitis, cough, bloat, diarrhea, canine influenza, parvo, seizures and sudden death. I acknowledge that in the event of my pet's illness, the staff at the Dragons Heart Kennels LLC may not be able to immediately contact me and is therefore authorized to initiate appropriate treatment of my pet(s) until I am available to discuss further care and costs with the veterinarian.

Owner further understands that not each and every potential risk can be listed above, nonetheless agree that the benefits associated with dog socialization, boarding and care outweigh the possible risks, therefore, owner hereby voluntarily releases, forever discharges, and agrees to hold harmless and indemnify Dragons Heart Kennels and it's agents, employees, successors, heirs, from any and all liability claims, demands, actions, or rights of action, which are related to, arise out of, or are in any way connected with their pet's participation in activities at Dragons Heart Kennels, including those allegedly attributable to the negligent acts or omissions of Dragons Heart Kennels and their staff.

Further, Owner understands that they may be exposed to certain risks when bringing their pets to participate in activities at Dragons Heart Kennels or when picking up or dropping off their pet to participate in activities at Dragons Heart Kennels. Such risks may include property damage and /or physical injury inside or outside the facility, such as from falling, slipping, illness and or dog bites. Therefore Owner hereby voluntarily releases, forever discharges, and agrees to hold harmless and indemnify Dragons Heart Kennels, it's agents, employees, successors or heirs from any and all liability, claims, demands, actions or rights of action, which are related to, arise out of, or are in any way connected with their pet's participation in activities at Dragons Heart Kennels, including those allegedly attributable to the negligent acts or omissions of Dragons Heart Kennels or their staff.

AUTHORIZATION OF MEDICAL CARE

If Owner's pet becomes ill or injured during a visit to or with Dragons Heart Kennels and their staff, Dragons Heart Kennels will attempt to contact the pet's personal veterinarian as well as the emergency contact provided to Dragons Heart Kennels by Owner, however, such an emergency might not provide the time to do so prior to the administration of care. Owner authorizes Dragons Heart Kennels to obtain medical attention for the pet from any veterinarian of Dragons Heart Kennels choice and to transport the pet to and from such veterinarian when Dragons Heart Kennels deems such medical care is important to the pet's health. Owner grants Dragons Heart Kennels and its employees or agent full authority to make decisions involving the medical treatment of pet and agrees to pay for all related costs. This applies to any claims for injuries or damages related to such medical care or that arise due to the transport of the pet.

*HEALTH AGREEMENT Owners initials_____

Owner specifically represent to Dragons Heart Kennels that, to Owner's knowledge, the pet has not been exposed to any contagious diseases within the 30 day period prior to check-in. Owner understands that each time pet is brought to Dragons Heart Kennels, Owner is recertifying that the pet is in good health and has not had any communicable illness of any kind for 30 days prior to check-in, and has not exhibited any signs of illness such as lethargy, coughing, vomiting or diarrhea within 48 hours prior to visiting. Owner further agrees to provide Dragons Heart Kennels with proof of required vaccinations upon request and prior to check in. Owner expressly certifies that pet(s) is current on all rabies vaccinations at time of service provided.

VICIOUS TENDENCIES Owners initials_____

I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON MY PET AT DRAGONS HEART KENNELS, I MAY BE UNABLE TO RETRIEVE MY PET AND WILL HAVE NO RECOURSE AGAINST DRAGONS HEART KENNELS. In addition, I understand that I will still be responsible for the unpaid charges incurred for my pet's stay.

All terms and conditions of this Agreement shall be binding on the heirs, administrators, personal representatives and assigns of the owner and Dragons Heart Kennels.

In signing this contract, owner authorizes pet's veterinarian clinic and/or veterinarian treating pet to discuss and/or release copies of pet's medical records to Dragons Heart Kennels and its staff.
